# 1. Minutes of the Dietrich School Council meeting held on January 16th, 2020.

The minutes of the January 16th, 2020 Dietrich School Council meeting were distributed electronically, moved, seconded, and approved.

#### 2. Dean's Report (Dean Kathleen Blee)

Dean Blee shared the Dietrich School's major accomplishments since the previous Council meeting.

The highlights are listed below:

- Jamie Hanson, Assistant Professor in the Department of Psychology and Research Scientist at the Learning Research and Development Center (LRDC), received the 2019 American Psychological Foundation Robert L. Fantz Memorial Award.
- Nicole Mitchell, Dietrich Professor of Jazz Studies in the Department of Music was named a 2020 USA Fellow by United States Artists. The award includes a \$50,000 unrestricted fellowship.
- Terence Smith, Mellon Professor in the Department of History of Art and Architecture was elected as a Board Member Emeritus for the Carnegie Museum of Art.
- Anjali Sachdeva, Lecturer in Department of English, was named a Literature Fellow by the National Endowment for the Arts (NEA).
- Robert Brandom, Distinguished Professor of Philosophy, book, A Spirit of Trust: A Reading of Hegel's Phenomenology, won the Jean-Pierre Barricelli Prize for the year's best book in the field of Romanticism studies.
- The Council for the Advancement and Support of Education (CASE) announced that Pitt's Study Lab: Revolutionizing the Story of Academic Success won the 2020 Silver Accolades Award under Institutional Marketing Identity/Branding Programs.
- B. Guy Peters, Maurice Falk Professor of Political Science, won the Anniversary Medal from Comenius University.
- Áurea María Sotomayor-Miletti, Professor of Hispanic Languages and Literatures won the essay category international award from the Casa de Las Américas, in La Habana, Cuba.
- Michael Hatridge, Assistant Professor of Physics and Astronomy, received a 2020 Alfred Sloan Research Fellowship.

Dean Blee recommended that the Dietrich School Full Faculty meeting scheduled for Monday, March 30th be cancelled due to the COVID-19 emergency. She explained that the election would take electronically, via Qualtrics. The agenda for the spring Full Faculty meeting will be moved to the fall 2020 meeting. The committee members voted to approve canceling the meeting.

Dean Blee praised the University's higher administration for responsiveness to the School's issues as we adapted to remote instruction and work. Dean Blee asked the committee to share questions or any major issues.

# 3. Assessment of Teaching Recommendations to Provost (Dean Blee)

The committee voted and agreed to discuss this item at the next Council meeting on April 14th, 2020.

#### 4. Nominating Committee (Dean Blee)

Dean Blee reminded the committee that nominations for the Dietrich School Nominating Committee will be collected over the summer.

### 5. Report from Dietrich School Graduate Council (Associate Dean Holger Hoock)

Dietrich School of Arts and Sciences Graduate Council met on February 13, 2020. Council reviewed and approved the report of the subcommittee that had reviewed TA/TF training and practices in the Department of Linguistics. Associate Dean Hoock provided background on the Dietrich School's priority of fostering a culture of support for graduate students' ambitious pursuit of external fellowships and updated Council on new and emerging resources and incentive mechanisms to further encourage external fellowship capture.

Council next revisited the Vice Provost Urban's request for school-level plans to assess the quality of graduate mentoring, reviewed a mentoring assessment survey shared by the Department of Psychology, and recommended delaying a school-wide mentoring assessment plan for further consultation next academic year.

Associate Dean Hoock will instead share with the Vice Provost this term the rubric for the Dietrich School's new mentoring award and any assessment tools shared by departments.

Associate Dean Hoock further updated Council on current DSAS strategic planning efforts and updates to the university budget model and encouraged Council members

to engage with ongoing consultative exercise for the Plan for Pitt 2025.

Finally, Associate Dean Hoock announced that the proposal he submitted with co-PIs from SSOE and SCI for a Chancellor's Special Cycle Seed Grant, "Culturally Sensitive Sexual Misconduct Prevention Programming for International Graduate and Professional Students," received full funding.

The report from the Dietrich School Graduate Council was motioned, seconded, and approved.

# 6. Report from Dietrich School Undergraduate Council (Associate Dean John Twyning)

Associate Dean Twyning shared highlights from the Dietrich School Undergraduate Council report. The highlights included that students will now be able to overlap up to 8 credits to count toward multiple majors or minors.

Associate Dean Twyning introduced guest Wesley Hiers to discuss the history of the new Law, Criminal Justice, and Society major. Wesley Hiers explained how this major is offered by both the Dietrich School and the College of General studies in the same format.

Dean Blee thanked Associate Dean Twyning and Wesley Hiers. She invited the committee to ask questions and share concerns.

Associate Dean Twyning invited committee member, Andrew Lotz, to briefly discuss the new Data Science major. Andrew Lotz explained that the major is collaborative with the School of Computing and Information and that it is in high demand.

Council voted to approve the report from Undergraduate Council.

# 7. Report on the College of General Studies (Associate Dean Twyning)

Associate Dean Twyning invited Executive Director of Undergraduate Studies, Jessica Hatherill, to discuss revisions made to non-College of General Studies credits. Executive Director Hatherill explained that the revisions were made to attract nontraditional students and that they will go into effect fall 2020.

#### Revision to the credit overlap policy

#### **Overlapping Credits**

- ➤ Up to eight credits may be overlapped between any two majors, two certificates, and/or a major and certificate.
- ➤ Up to eight credits may be overlapped between a major and minor and/or certificate and minor.
- Up to four credits may be overlapped between two minors.

### Revision to the grade requirement for the Theatre Arts major

# 1. Minutes of the Dietrich School Council meeting held on March 18, 2020

The minutes of the March 18<sup>th</sup>, 2020 Dietrich School Council meeting were distributed electronically, moved, seconded, and approved.

#### 2. Dean's Report (Dean Kathleen Blee)

Dean Blee shared the Dietrich School's major accomplishments since the previous Council meeting. The highlights are below:

• Kathryn Fleisher, student in the Department of Philosophy, has been awarded a 2020 Harry S. Truman Scholarship. She's one of only 62 college students in the country to win the prestigious award and the 13th in Pitt's history. The competitive national scholarship awards \$30,000 for two to three years of graduate study.

- Yona Harvey, Assistant Professor in the Department of English, received a poetry fellowship from the George A. and Eiiza Gardner Howard Foundation at Brown University for the 2020-21 academic year. Harvey has won a fellowship in the poetry category.
- Graham Hatfull, Professor in the Department of Biological Sciences, was elected as a member of the American Academy of Arts and Sciences

Dean Blee praised the Dietrich School faculty for their rapid response to remote teaching. She reported that admissions for the first year class look strong at this point, that the Dietrich School is participating in discussions regarding logistics of returning to campus when that is allowed, and that the Dietrich School will host an in-person gathering to welcome faculty and staff back to campus and recognize those who made particularly heroic efforts to support our mission during the pandemic crisis.

#### 3. Nominating Committee (Dean Blee)

The Nominating Committee is charged with finding candidates to run for all committees in the Dietrich School. The process has been streamlined to be more efficient and the overall task of Nominating Committee has been aided by Next Step Alerts.

Dean Blee explained that the slate needs three Tenure/Tenure Stream faculty and two Appointment Stream faculty for each division. She asked Council members to please submit candidate names to Alyson Sved.

## 4. Assessment of Teaching Recommendations to Provost (Dean Blee)

Dean Blee addressed questions and concerns pertaining to each of the teaching recommendations to the Provost. These recommendations were created prior to the remote teaching shift for COVID-19 and will be revisited in the fall, once more information is available about remote learning from the spring and summer semesters. Council was asked to share thoughts on the recommendations in the report. Council discussed the value of a repository for all forms of teaching assessment, in addition to the OMETS and the need to consider how teaching evaluations will be handled during future evaluations in uncertain situations.

### **5.** Change in Minutes Approval Process (Dean Blee)

Dean Blee proposed an email voting and approval process for Council meeting minutes. The council agreed and the process was approved.

# 6. Faculty Grants Committee Election (Associate Dean Holger Hoock)

Associate Dean Hoock shared the role of the Faculty Grants Committee and explained that the committee will begin to meet once per semester, starting this fall.

Council members will vote electronically, and the results of the election will be included in the May 2020 Gazette.

### 7. Report from Dietrich School Graduate Council (Associate Dean Hoock)

Graduate Council met via Zoom on April 23, 2020. Council approved a proposal from the Department of Statistics to reduce the credit requirements for its four master's programs from 33 to 30 credits so as to bring requirements in line with those of peer programs.

Council also approved a proposal from the Department of Chemistry to create five new Areas of Concentration (ARCOs) to represent a formalization of existing disciplinary emphases. Council next received and approved the response of the Department of English to Council's consultative review of TATF orientation, training, and support practices.

Associate Dean Hoock then updated Council in detail on the University's and Dietrich School's responses to the global pandemic with regard to graduate students. He highlighted the significant and collaborative efforts of graduate students and faculty in response to the global pandemic and acknowledged the disruption to many research programs as students collaborate with advisors and committees to adjust and maintain momentum as feasible, the additional challenges faced by graduate students juggling childcare, and concerns that come with separation from wider family and other support networks, especially for our international students.

Associate Dean Hoock provided detailed updates, and responded to members' queries, pertaining to communications and general resources for graduate students, including in support of graduate student mental health; Office of Graduate Studies remote operations; the pivot to remote instruction; continuity of research and of summer research funding without travel; a strictly opt-in protocol for graduate students and postdoctoral trainees to

be considered for research-related essential tasks in science labs; University-level emergency support; and scenario planning for summer clinical experiences, research rampup, and fall-term instruction. Finally, Associate Dean Hoock thanked all members of Council for their service throughout the year and especially during recent trying times.

Associate Dean Hoock also noted that eight DSAS Graduate Students have been awarded NSF GRFs. Robin Zwier, Department of Communication, won an AAUW Dissertation Fellowship.

The report from the Dietrich School Graduate Council was motioned, seconded, and approved.

#### 8. Report from Dietrich School Undergraduate Council (Associate Dean John Twyning)

Associate Dean Twyning shared highlights from the Dietrich School Undergraduate Council report. He then discussed updates on the new majors and certificates listed in the Dietrich School Undergraduate Council Report. Council voted to approve the report from the Undergraduate Council.

# 9. Report on the College of General Studies (Associate Dean Twyning)

The College of General Studies Council has not met since February 21, 2020. There is no new report.
