## Report of the Secretary of the Tenure Council

Between September 1, 2007 and August 31, 2008 a total of 40 *ad hoc* Review Committees were convened to advise the Dean of Arts and Sciences on cases for promotion to Associate Professor with tenure, appointment at senior rank, or promotion to full Professor. The members of these Committees were chosen by the Tenure Council Selection Committee and the Dean of Arts and Sciences in accordance with the Arts and Sciences Bylaws. In the previous 10 years, the number of *ad hoc* Review Committees was as follows:

Twelve Committees were convened to advise the Dean on departmental recommendations that Assistant Professors be promoted to the rank of Associate Professor and awarded tenure; two of the cases were brought to the Dean before the statutory deadline and two were second committees providing advice with respect to cases that had been denied the previous year (one of these was convened on the recommendation of the Provost following his review of the report of an appeals panel with respect to the case). Eight Committees voted unanimously to sup-

port the departmental recommendations; one committee voted three for and two against a departmental recommendation for promotion and award of tenure; one committee voted three for and three against; one committee voted two for and four against; and one committee voted zero for and six against.

The Dean denied promotion to the rank of Associate Professor and the award of tenure to four candidates, one of whom did not have the support of their department; no *ad hoc* was convened in respect of this case. Two candidates have asked for reconsideration and were both denied tenure after reconsideration. One of those cases is under appeal.

Sixteen *ad hoc* Review Committees were convened to advise the Dean on departmental recommendations for promotion of tenured Associate Professors to the rank of full Professor. Fourteen *ad hoc* Review Committees voted unanimously in favor of the departmental recommendations. Two committees voted four for and one against a departmental recommendation for promotion and award of tenure. The Dean has acted on three of the 14 positive recommendations; he has forwarded three positive recommendations to the Provost. The remaining 11 cases are still under review.

Twelve Review Committees were convened to advise the Dean on departmental recommendations to appoint new faculty members at the rank of Associate Professor with tenure, full Professor with tenure, or Distinguished Professor. Twelve Committees voted unanimously in favor of the departmental recommendations. Twelve candidates were offered positions and two candidates accepted; three offers are still under negotiation.

The Arts and Sciences Tenure Council Standing Committees were used 11 times. Nine Standing Committees were convened to advise the Dean on outside hire recommen-

dations and two were for promotion. The Humanities Standing Committee was convened to hear five cases, the Natural Sciences Standing Committee for two cases, and the Social Sciences Standing Committee for four cases.

An Appeals Panel drawn from the membership of Tenure Council was convened by the Office of the Provost to hear an appeal of a promotion denial by one faculty member. The Panel reported to the Provost, and the Provost upheld the denial.

The Arts and Sciences Tenure Council for 2007-2008 consisted of 41 regular members and 32 alternate members. These individuals were called on for service on *ad hoc* Review Committees as follows: 33 members served on at least one committee, 19 served on only one Committee, eight on two, 12 on three, nine on four, one on five, and three on six. In addition, 54 other faculty members from Arts and Sciences and four faculty member from other schools served on *ad hoc* Review Committees during the academic year.

**1. Minutes of the Meeting Held on March 17, 2008**

Dean Cooper presented the minutes of the meeting held on March 17, 2008. Professor Jean Ferguson Carr made a motion to approve the minutes. Professor Jonathan Scott seconded the motion and it was carried unanimously.

**2. Dean's Report**

The Dean's report was tabled until the next meeting.

**3. Report on Assessment Process for Majors and General Education Requirements**

Associate Dean Manfredi reported that as of today he has received 62 of the 68 matrices that he had solicited for the courses used to fulfill the General Education Requirements. He noted that the next step in the assessment process would be for the Arts and Sciences Deans to review the matrices, followed by Undergraduate Council, and implementation would occur during the next academic year.

Associate Dean Manfredi reminded Council that this is the year that Departments were to implement assessment of undergraduate majors. He mentioned that Dean Cooper sent a memo to Chairs and Program Directors requesting their completed matrices by May 9. Associate Dean Constable noted that this also applied to graduate majors.

**4. Report from Arts and Sciences Undergraduate Council**

Associate Dean Manfredi reported that Undergraduate Council met on March 28, April 1, and April 15. He noted that they approved 20 new courses and approved the use of three existing courses to fulfill a General Education Requirement. He also mentioned that this year's Bellet Award Winners were Melanie Dreyer-Lude and Jeff Oaks.

Associate Dean Manfredi presented a resolution on behalf of Undergraduate Council in which Council proposes that the number of scheduled final examinations a student must take in one calendar day should be limited to two. Council discussed this matter, and Dean Cooper noted that if they accepted this resolution he would write a recommendation letter to the Provost.

Professor Mathew Rosenblum moved to accept Associate Dean Manfredi's report so that the next steps could be taken. Professor Jonathan Scott seconded the motion and it passed with one abstention.

**5. Recommendation to Faculty Regarding the Use of Turnitin Paper Submission Software**

Associate Dean Manfredi presented a draft of a resolution regarding the use of Turnitin Paper Submission Software approved by Undergraduate Council on

April 15. He presented background information on the software program, and noted that students at other institutions have taken unsuccessful legal action against Turnitin, claiming it violated intellectual property and privacy rights. The following resolution would be inserted into the syllabus of any course where the Turnitin software is used, providing full disclosure:

1. *The following paragraph taken from the Registration Agreement between iParadigms and the University of Pittsburgh should be added to the course syllabus of each course making use of the Turnitin service:*

*Students agree that by taking this course all required papers may be subject to submission for textual similarity review to Turnitin.com for the detection of plagiarism. All submitted papers will be included as source documents in the Turnitin.com reference database solely for the purpose of detecting plagiarism of such papers. Use of Turnitin.com page service is subject to the Usage Policy and Privacy Pledge posted on the Turnitin.com site.*

2. *Reasonable efforts should be made to respect the privacy of the students by encouraging coding mechanisms that hide the identity of the author of the paper.*

Council discussed the resolution, and felt that the section regarding privacy might be too ambiguous. Dean Cooper noted that Council could endorse the first section of the resolution, and proposed that the second section be reworded to read:

*Faculty are encouraged to accommodate students who wish to use pseudonyms to protect their privacy.*

Professor Jean Ferguson Carr moved to accept the recommendation to have this reworded resolution added to the syllabi of courses using the Turnitin software. Professor Linda Jen-Jacobson seconded the motion and it was approved unanimously.

## 6. Report from Arts and Sciences Graduate Council

Associate Dean Nicole Constable reported that Graduate Council met on April 11. They approved the TA/TF reviews for the Department of Chemistry and the Department of Physics and Astronomy and forwarded that information to the Departments.

Council also reviewed a proposal for a Jazz Studies concentration in the Department of Music. They agreed that this was well aligned with the program. Council had questions regarding the budget and logistics, and it was recommended that the Department look into these concerns. A vote was held—seven members voted to support the proposal and one member abstained from voting.

Associate Dean Constable also reported that Council discussed and approved the name change from “Germanic Languages and Literatures” to “German Studies” with respect to the MA and PhD degrees within the Department of Germanic Languages and Literatures. Dean Cooper noted that he would forward this information to the Provost.

Professor David DeJong put forth a motion to accept the report from Arts and Sciences Graduate Council. That motion was seconded by Professor Jean Ferguson Carr and was carried unanimously.

## 7. Other Business

### 1. Minutes of the Meeting Held on April 21, 2008

Dean Cooper presented the minutes of the meeting held on April 21, 2008. Professor Linda Jen-Jacobson made a motion to approve the minutes. Senior Associate Dean Knapp seconded the motion and it was carried unanimously.

## 2. Dean's Report

- **Keiko McDonald**, a professor in the Department of East Asian Languages and Literatures, passed away on September 14, the result of an accidental drowning. She was an avid fisher and noted for her teaching and scholarship on Japanese literature and Japanese film. Her distinctions included the Tina and David Bellet Undergraduate Teaching Excellence Award, three Fulbright Research Fellowships, and a National Endowment for the Humanities Summer Research Award.
- **Yadin Goldschmidt**, a professor in the Department of Physics and Astronomy, passed away on August 30, 2008. He received his PhD from Hebrew University of Jerusalem in 1978.
- **George Reid Andrews**, a professor in the Department of History was recently promoted to the rank of Distinguished Professor of History in recognition of his contributions to the history of Latin America.
- **Nuel D. Belnap Jr.**, Alan Ross Anderson Distinguished Professor of Philosophy in the Department of Philosophy, was elected a Fellow of the American Academy of Arts and Sciences in the 2008 class.
- **Marcus Rediker**, a professor in the Department of History, was awarded the George Washington Book Prize for his book, *The Slave Ship: A Human History*.

## 3. Election of Arts and Sciences Council Member as Vice Chairperson to Serve in Dean's Absence

Dean Cooper reminded members that in Section III.7 of the Arts and Sciences Bylaws, it states that "The Council shall elect one of its members each year to be Vice Chairperson, who shall preside at the meetings of A&S Council and of the faculty in the absence of the Dean". Dean Cooper asked for nominations or volunteers for the position of Vice Chairperson. Senior Associate Dean Knapp was nominated for this position by Professor Stuart Hastings. Professor Marcus Rediker put forth a motion to re-elect Senior Associate Dean Knapp as Vice Chairperson. That motion was accepted unanimously.

## 4. Slate for Nominating Committee

Dean Cooper summarized the role of the Nominating Committee and read the relevant sections from the Arts and Sciences Bylaws (Arts and Sciences Bylaws, Section III.13). He reminded Council members that a slate of candidates was to be advertised as per the Bylaws, and presented at the fall meeting of the faculty of the School of Arts and Sciences, after which the Nominating Committee of six members (two from each division of Arts and Sciences) shall be elected by ballot. The faculty member with the most votes from each Division also serves as an Arts and Sciences representative on the Senate Committee for Elections for a two-year term. Dean Cooper outlined the duties of the Nominating Committee and the charge to that Committee, so that members of Council would be able to explain this involvement to nominees from their division. Dean Cooper also pointed out that faculty members who served on the Nominating Committee in the previous year are not eligible to serve this year. He then asked for nominations from Council of suitable candidates for the Nominating Committee, and suggested that as many departments as possible should be represented on the slate of nominees.

Council members then prepared a rank ordered list of nominees for the Nominating Committee. One Council member from each division agreed to contact these nominees to ascertain their willingness to serve if elected.

## 5. Report from Arts and Sciences Undergraduate Council

Senior Director of Undergraduate Studies Judith McConnaha reported that the Arts and Sciences Undergraduate Council has not yet met.

## 6. Report from Arts and Sciences Graduate Council

Associate Dean Constable reported that the Arts and Sciences Graduate Council has not yet met.

## 7. Set Dates for Full Faculty Meeting

The date of Wednesday, October 29, 2008, from 1 to 3 p.m., was selected by Council.

### 8. Appoint Arts and Sciences Council Member from Natural Sciences to the Arts and Sciences Planning and Budgeting Committee (A&S-PBC)

Dean Cooper outlined the structure of the membership of the Arts and Sciences Planning and Budgeting Committee and said that the elected members serve three-year terms. He pointed out that it is necessary to elect a member of Council from the Natural Sciences division to serve on the A&S-PBC.

Professors Linda Jen-Jacobson and Stuart Hastings were nominated to serve. After a vote, Professor Jen-Jacobson was declared the Natural Sciences representative on the A&S-PBC.
