# Faculty Research Grants 2007 Competition

The Faculty Grants Committee announces that support will once again be available in fiscal year 2007-08 for Arts and Sciences faculty research projects in the humanities, social sciences, and natural sciences, including proposals of an inter-disciplinary nature.

The application deadline is **Wednesday, January 31, 2007**,

though the Committee would appreciate having applications as soon as possible.

Individual grants will be made in two categories:

**Type I. Third Term Research Stipends of \$4,000** for research activities in lieu of teaching. The purpose of this type of grant is to enable faculty members to be free from teaching duties during the Third Term in order to work full time on research projects.

**Type II. Research Expense Grants** in support of specific project expenses such as microfilming, research materials, travel to libraries and other sources of information and clerical assistance. Actual expenses from \$100 to \$3,500 will be considered. Full funding, even for successful proposals, cannot be guaranteed.

**Eligibility** is limited to tenure-stream or tenured Arts and Sciences faculty on the Oakland campus. Restrictions regarding eligibility for Type I and Type II funding are specified later in this announcement. Please read these carefully. **Applications** for both types of grants must be received by the Committee Co-Chairs by Wednesday, January 31, 2007. **No late proposals will be accepted**. All applicants will receive confirmation that their application has been received. For Type II grants, no funds can be disbursed until July 1, 2007; however, the research projects of grant recipients may begin before that date. For Type I grants, stipends will be included with July 31, 2007 paychecks <u>unless</u> funds become available which may allow the stipends to be included in May and/or June salaries. Awards will be announced in the beginning of April. Unfortunately, this Committee cannot provide applicants with individual evaluations of proposals.

**Application Format and Restrictions** are explained in the following paragraphs of this announcement. # ELIGIBILITY & APPLICATION PROCEDURE

# TYPE I. THIRD TERM RESEARCH STIPENDS OF \$4,000

To be eligible for a Type I stipend the applicant must not be employed during the Third Term in any way which makes it impossible to devote maximum time to research. Priority is given to faculty in the lower ranks and to those who have not previously received such a grant. Research projects for which funds are generally available from other sources will receive low priority.

**Application Format:** The application consists of four parts: (1) A cover sheet and current CV, including mention of all previous grants with amount and year; (2) an abstract summarizing the proposal in simple terms; (3) the proposal itself; and (4) a title sheet and self-addressed (campus) envelope. No application will be accepted unless it contains a current CV.

- 1. The cover sheet should be appended to a current CV and include the following information in the order listed here: (A) name of applicant, (B) faculty rank, (C) department, (D) university mailing address and extension, (E) applications pending or funding expected for the same period or the same research, (F) type of grant (I or II), and (G) title of research project. Please indicate previous funding, both internal and external. Faculty members who have received an Arts and Sciences grant within the last five years should also submit a brief (one to two paragraph) statement describing the results of the project(s) funded.
- 2. <u>The abstract</u> (100-200 words) should summarize the proposal in simple terms.
- 3. The proposal should be written in such a manner that members of the Committee who are not experts in your field can understand your proposal. Technical jargon should be avoided. Applicants are encouraged to bear in mind that the evaluators represent a wide range of disciplines in the humanities, natural sciences, and social sciences. The proposal should contain: (A) a statement of the problem; (B) the objectives and expected significance of the research; (C) if applicable to your field, the relationship of the research to the present state of knowledge in the field (with appropriate bibliographic references), a description of your own related previous work or, for applicants in writing or the arts, representative samples of your work; and (D) methods or procedure (how you expect to reach the stated objectives) and, if applicable, a description of data collection techniques and analysis. The proposal itself should be limited to six double-spaced pages including bibliographic references. No offprints, photocopies, tapes or other examples of previous work should be enclosed. Proposals that do not follow this format will not be reviewed.
- 4. <u>The title sheet and self-addressed envelope</u> will be returned to the applicant to verify receipt of the proposal.

**Copies:** Twelve copies of the application should be sent to either of the Committee Co-Chairs, Ann Sutherland Harris (Department of History of Art & Architecture/ 105 Frick Fine Arts Building) or Andrew Weintraub (Department of Music/305 Music Building).

# **TYPE I. RESTRICTIONS**

Faculty members who have contractual obligations, including cash advanced for writing, or those engaged in traditionally compensated Third Term teaching or administrative assignments, or with other University or sponsored research summer salary support, are not eligible for these grants.

Grants are not given for projects known to be lucrative commercial ventures, dissertation research, or curriculum development.

# TYPE II. RESEARCH EXPENSE GRANTS

Type II grants are given to cover specific research project expenses for which other sources of funding are not available. Priority is given to faculty in the lower ranks and to new research projects; however, well-justified expenses for successful projects in the later stages of development are also considered.

**Application Format:** The application format for a Type II grant is the same as for a Type I grant, with the addition of a detailed budget.

**The Budget:** On a separate page, the project expenses should be itemized and justified in reasonable detail. Travel expenses should be explained in detail; transportation costs will be limited to coach class airfare. Applicants should submit the most recent airfare quotes from one of the University-designated travel agencies.

**Copies:** Twelve copies of the application should be sent to either of the Committee Co-Chairs, Ann Sutherland Harris (Department of History of Art & Architecture/ 105 Frick Fine Arts Building) or Andrew Weintraub (Department of Music/305 Music Building).

# **TYPE II. RESTRICTIONS**

Type II grants are not given for:

- travel for the purpose of attending conferences or symposia
- projects known to be lucrative commercial ventures
- dissertation research
- curriculum development
- travel for purposes of research that is otherwise funded
- materials or equipment which can be borrowed or are readily available locally
- typing of manuscripts

Library materials acquired under a grant are to be deposited in the University library when they are no longer needed for the project.

# 1. Minutes of the Meeting Held on March 22, 2006

Dean Cooper presented the minutes from the A&S Council meeting held on March 22, 2006. Associate Dean Constable requested that a change be made to reflect "TA TF training and evaluation" instead of "recruitment." Marla Ripoll then put forth a motion to accept the minutes with the correction. This motion was seconded by Jean Ferguson Carr and carried unanimously.

# 2. Dean's Report

Dean Cooper noted that Arts and Sciences was nearing the end of recruiting season and indicated that he would make a full report at the end of the year. He congratulated the Department of History and Philosophy of Science for placing all 10 of their graduating doctoral students—nine have accepted tenure stream positions and one has accepted a two-year postdoctoral position at Yale.

# 3. Report from A&S Undergraduate Council

Dean Cooper noted that Associate Dean Schulte-Ladbeck is out of town and that he would be presenting the report from A&S-UC on her behalf.

Dean Cooper reported that the spring-term proposal deadline to A&S-UC was April 1. The Associate Dean for Undergraduate Studies received 20 proposals for new courses, and two proposals for existing courses to fulfill a general education requirement. In addition, there were 20 requests for the new courses to be approved to fulfill general education requirements (note that some courses had multiple general education listing requests).

A&S-UC met three times between April 1 and April 18, 2006. The last meeting was held jointly with the Chair of the College Writing Board, Beth Matway, in order to integrate the board's comments on the quality of three W requests into the deliberations of Council.

Undergraduate Council approved 14 courses, and rejected three. Council requested that the Associate Dean collect more information on the course proposals for two courses. One proposal remained an incomplete submission and was not forwarded to A&S-UC for discussion.

Council also approved 15 requests for courses to fulfill general education requirements, including all three W requests, and rejected three. The remaining four requests pertained to courses which were incomplete, or for which the Associate Dean was asked to collect more information.

A&S-UC discussed and approved a request by Professor David Pratt (Chemistry) to modify the wording of the general education requirement in the natural sciences. A motion to change the wording of the general education requirement in the natural sciences had been discussed by A&S-UC in February, but that motion was not supported. This is a new motion, and it was supported. According to Professor Pratt, this proposal was endorsed by the natural science chairs. This proposal will be presented to A&S Council at its September meeting for possible inclusion on the agenda for the fall full faculty meeting. Dean Cooper noted that A&S Council should formally solicit the advice of the natural science chairs. This idea was supported unanimously, and Professor Juan Manfredi agreed to contact the chairs.

A&S-UC also discussed and recommended moving the spring proposal deadline up to March 15, which will generally fall in the week after spring break. This would give A&S-UC and CWB more time to complete their business before the last meeting of A&S Council in the spring term. The motion to change the deadline to March 15 was supported unanimously by A&S Council.

Franklin Toker put forth a motion to accept the report from A&S-UC. This motion was carried unanimously.

# 4. Report from A&S Graduate Council

Associate Dean Constable reported that the A&S Graduate Council met on April 17, 2006. Professor Sandra Mitchell, Chair of the Department of History and Philosophy of Science, attended this meeting as a guest speaker on the topic of placement strategies for graduate students.

A&S-GC discussed the criteria for nominations of graduate faculty. Associate Dean Constable reported that there have been inconsistencies in the criteria for graduate faculty nominations and noted that A&S-GC is exploring different approaches to resolving the problem in different departments. Associate Dean Constable also noted that departments in the humanities and social sciences protect junior faculty from being nominated while departments in the natural sciences encourage junior faculty to be involved at the graduate level. Assistant Dean Robert Walters and Associate Dean Constable will compare the Arts and Sciences process to those of other schools within the University.

Associate Dean Constable reported that the report for Computer Science TA/TF training has been completed. Professor Peter Koehler put forth a motion to accept the report from A&S-GC. This motion was carried unanimously.

# 5. Review of Departmental Bylaws

Associate Dean Knapp listed the departments that have not submitted their bylaws for review.

Associate Dean Knapp presented draft bylaws for the departments of German, Philosophy, Hispanic Languages & Literatures, Women's Studies, and the revised version of the bylaws of the Department of Africana Studies. Associate Dean Knapp again emphasized that the main goal of requiring departments to maintain and follow bylaws is transparency.

Dean Cooper noted that in the case of Women's Studies, programs were not required to submit a set of bylaws and explained that extension of the requirement to include programs would require that Council establish new criteria for their review.

Jonathan Scott put forth a motion to accept Associate Dean Knapp's report. This motion was seconded by Joseph Adjaye and carried unanimously.

# 6. Completion of Review of Departmental Bylaws

Dean Cooper noted that although Arts and Sciences had neared the end of its academic term Associate Dean Knapp is waiting to receive bylaws from three additional departments. He asked that Council continue the conversation concerning bylaws at the start of its next term. Dean Cooper put forth a motion that Associate Dean Knapp be given a mandate to act on behalf of Council over the summer to get all the departmental bylaws in place for the September 1 distribution date. This motion was seconded by Peter Koehler and carried unanimously.

# 7. Other Business

With no other business the meeting was adjourned at 2:18 p.m.

# 1. Overview of A&S-UC Responsibilities for New Members

Associate Dean Schulte-Ladbeck provided an overview of A&S-UC's history, responsibilities, and role for the benefit of new members and to refresh the memories of returning members. She and returning members provided online resource information for new members to refer to when reviewing proposals.
